

ADOPTION CONTRACT

TERMS AND CONDITIONS

Please Initial After Each Statement

1. The adopter agrees that the animal will be kept only as a personal pet and companion animal, not as a fit, working pet, or chained guard dog, and NEVER TO BE USED FOR RESEARCH PURPOSES. The adopter also agrees to provide adequate fresh food and water and daily exercise. _____
2. The adopter grants Mike Westbrook the right to make periodic visits to the adopter's premises for the purpose of checking on the health and general welfare of the animal and to verify that the animal has been spayed/neutered in accordance with the terms of this agreement. Sterilization of the animal is required under chapter 828, Health and Safety Code, State of Texas. Violation of the chapter is a criminal offense punishable as a Class C misdemeanor. _____
3. The adopter grants Mike Westbrook the right to a home visit exactly one year after the pet is adopted. The adopter also agrees to send or bring pictures for a visual update on the status of the pet. _____
4. The adopter represents that all family members have agreed to the adoption of the animal and that all family members will abide by the terms of this agreement. The adopter further represents that he/she is twenty-one years of age or older. _____
5. The adopter agrees to provide all medical care and treatment needed by the pet. This includes medical checkups and routine vaccinations as well as care during illness or injury, _____
6. If for any reason the adopter is unable to provide all care for the animal, the adopter agrees to RETURN THE ANIMAL TO Mike Westbrook only. _____
7. The adopter represents that he/she has never been subject to legal action for cruelty to or neglect of animals. The adopter further represents that he/she has never owned an animal, which has been confiscated by any animal control or humane organization for violations of state or local animal control regulations or animal adoption agreement. _____
8. The adopter shall not offer the animal for sale or give the animal to any third party without written consent of Mike Westbrook.
9. The adopter agrees that Mike Westbrook shall have the right of immediate possession of the animal if, and in the judgment of Mike Westbrook, the animal is receiving inadequate care, is being improperly housed or handled, or has not been spayed or neutered. _____
10. The adopter agrees that Mike Westbrook makes no claims as to the temperament, health or mental disposition of any animal put up for adoption; therefore, any information given to the adopter is based exclusively on the spent at the Westbrook home or information obtained from the person relinquishing the animal or upon examination by our veterinarians.
11. The adopter agrees to license the animal in accordance with local laws and ordinances. _____
12. The adopter agrees to provide a safe collar with an identification tag showing the adopter's address and telephone number. _____
13. The adopter acknowledges receipt of a copy of the adoption contract at the time of adoption. _____
14. The adopter agrees that if they move at any time within the lifetime of the pet, they will contact Mike

Westbrook to update their information including phone number, address and city/state where they will be residing._____

15. The adopter hereby accepts possession of, title to (subject to the condition of the adoption contract), and responsibility for the animal adopted and agrees to release and discharge Mike Westbrook permanently from liability for any injury or damages to any person or property caused by the adopted animal, and from any causes of action, claims, suits, or demands, whatever may arise as a result of such injury or damages._____

By signing below, I hereby submit that the information provided by me is true. Any false information may result in my losing the privilege of adopting a pet. I understand that Mike Westbrook has the right to deny my request to adopt an animal and that this application must be completed and approved by Mike Westbrook, before the animal adoption may be finalized.
